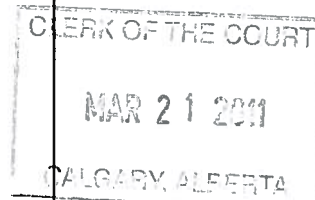

ORDER FOR DISTRIBUTION OF FUNDS TO TRACEABLE CLAIMANTS

UPON THE APPLICATION of the Plaintiffs; IT IS HEREBY ORDERED THAT:

1. Class Co-Counsel shall pay to the Class Members listed on Schedule "A" to this Order, the amounts noted on Schedule "A", as well as a reasonable estimation of the pro-rata share of any interest on those funds (the "**Further Directly Traceable Claims**");
2. Class Co-Counsel shall be permitted to deduct their fees of 33.3% from each of the Further Directly Traceable Claims, prior to issuing payments to Class Members;
3. Plaintiff Class Counsel shall give notice to all recipients of Further Directly Traceable Claims payments of their right to object to Class Counsel's fee and the process for doing so, and shall also advise such Further Directly Traceable Claims recipients that unsuccessful objections may give rise to liability in costs.

4. Costs of this application shall be in the cause.
